FOREST PARK CIVIC ASSOCIATION

(Name of Corporation)

The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation not for profit, under Sections 1702.01 et seq., Revised Code of Ohio, do hereby certify:

FIRST. The name of said corporation shall be Forest Park Civic Association

SECOND. The place in Ohio where the principal office of the corporation is to be located is

ColumbusFranklin

County

(City, Village or Township)

THIRD. The purpose or purposes for which said corporation is formed are:

(1) To promote, conserve and maintain the general and cultural welfare of the residents of the area known as Forest Park in City of Columbus, Ohio, by giving special attention to public improvements and their betterment and to all that relates to the health, safety, welfare, convenience and comfort of the said residents, and to encourage social, civic, educational, and recreational activity among said residents.

(2) To provide places and facilities for said cultural, educational, physical, civic, and recreational activities of the members of the Forest Park Civic Association, their families and friends, and to acquire by purchase, lease, gift or otherwise real estate and appurtenances, buildings, or other facilities, and to own, hold, develop, improve, utilize and dispose of such property in carrying out the purposes of the association.

(3) To acquire by purchase, lease or gift or otherwise and hold, own and maintain real estate or any interest therein for the development or improvement as parks and playgrounds, garden spots, or grounds for picnics, gardens, shows and other uses.

(4) To do all things necessary or incidental to the purposes of this association and in furtherance thereof, to receive any and all types of property by bequest, gift, or authorized assessment of the members of this association, or by any other lawful means, and to expend and disburse money and in and all types of property for the accomplishment of the purposes of this association.

FOURTH. The following persons, not less than three, shall serve said corporation as trustees until the first annual meeting or other meeting called to elect trustees.
