Happy New Year Forest Park! I enter 2016 serving both as your Civic Association's Vice President and Northland Community Council (N.C.C.) Representative while maintaining my duties from last year as your Supplemental Security Officer and I am happy to serve; especially with Ed Vanasdale as our new Forest Park Civic Association President! Kudos also go to our immediate past President Ken Gilbert for his work on our behalf.

I also want to take a moment to ask everyone reading this article this month that the Civic Association needs your help in any capacity you care to help in. We are a volunteer association representing some 2900 households and on average, in the 3 years I have lived in Forest Park and been involved with the civic association, we have had an average of 14-25 households represented either on the board or who serve as volunteers. My dear neighbors, that is less than 1% of the neighborhood carrying the weight and yet I know that there are so many others out there who care and want to be involved. The work it takes to lobby the city for better roads, more police patrols, sidewalks, curbs, better lighting in problem areas, and a host of others, needs more hands at the wheel.

Please come join us on the second Tuesday of every month at 7pm at the Epworth Methodist Church on Karl Rd and see how much of a difference we make and can continue to make in our neighborhood with the partnerships we have created with the City of Columbus, and the Columbus Police Department and the influence those partnerships allow our organization to have in ensuring we continue to have a neighborhood we all enjoy living in. Please give me a call at 614-595-7871 or call our President, Ed Vanasdale at 614-537-2182 if you would like to pitch in and help us do the work of maintaining this wonderful neighborhood we all love and call home.

On the security side of things in our neighborhood, we continue to be relatively quiet and our Columbus Police Neighborhood Liaison Officer strongly believes that the work the civic association has done together with the Columbus Police Department to close down nuisance hotel properties and other businesses in our area, has served to eliminate a base of operation for much of the criminal element that had plagued our area in the past. You can find the true facts regarding crime in Forest Park by using the website http://www.raidsonline.com, put in your address when the screen pops up and you can get crime date in our area. Forest Park looks very good on this map as a neighborhood to live in and it takes all of us to pitch in to make it even better.

Lastly, I have noticed; and I am sure many of you have as well, that many of our neighbors are parking cars in their yards. I get at least 5-10 reported instances in the report from our private security patrol company. Not only is this not pleasing to the eye as one drives through our neighborhood; but it is also a violation of Columbus City Code for which one can be fined. What can you do if you see cars parked in a neighbor's yard? Let's try doing the neighborly thing first and remind them that it detracts from the beauty of our neighborhood and if your friendly requests fall on deaf ears, you can call 311 to file the complaint with City Code Enforcement or do the same online at https://311.columbus.gov.





Public Utilities Commission of Ohio visits January FPCA Meeting

Luka Papalko, from the Ohio Public Utilities Commission, spoke at our January meeting. He was there to answer questions and to speak about the Energy Choice program, where customers can choose their energy providers (electric and natural gas). While the PUCO does not (and cannot) recommend a specific energy supplier, their website (http://www.energychoice.ohio.gov/) does have information so that the consumer can make an educated choice.

Often solicitors will come to your door to ask you to switch providers. The companies are required to get a permit in areas and the solicitors are required to wear a badge from their companies (as well as the required city soliciting permit badge). The companies do background checks on the individuals they send out and the companies also have to register with the PUCO to be allowed to solicit. The solicitors should have a name badge, some form of certification and usually shirt/clothing matching the company that they're with.

If there is an issue with the solicitors violating the city ordinances as far as time and place go (which includes not having a Columbus city permit), alert your local authorities. However, if the solicitors are following the ordinances/rules but do not have photo id or are being aggressive, misleading with information, or anything in that regard with their sales pitch, that's when you should contact PUCO. Whether we personally like the people coming or going, it is always a healthy sign when our county changes presidents. It refreshes our respect for the rule of law and keeps the ultimate power to its citizens. Leadership change in our civic association may not be as dramatic, but is equally important. It shows both a depth and strong commitment from within the organization.

Ed Vanasdale assumed the leadership role of FPCA this past January and the neighborhood is lucky to have his commitment. Moving out of the office is Mr. Ken Gilbert. Assuming the title of Past President, he will be no less active in FPCA, although his phone might ring a bit less.

I first met Ken and his wife, Cate, years ago when I was Vice President. The couple responded to the need for membership volunteers. Their service led to the offer of Ken's role as an area representative. When I assumed the president's position, Ken stepped up to become Vice President, leading him to his presidential tenure the past two years.

The great thing about Ken is that he is always Ken, no matter the circumstances. He's deliberative, intuitive, and patient. No matter the level of contention, he never takes things personally. Such characteristics allow him to look for solutions that serve the best interest for all parties. I'm embarrassed to recall one incident where I made a rather harsh suggestion to Ken on what action to consider with a neighborhood impasse. He responded to me that he was going to try a different approach: working with them. Ultimately his strategy proved to be the right choice.

With peaceful unity came relentless persistence. Ken and the board kept the city accountable for key maintenance matters until completion. I'm reminded of that every time I drive on Sandalwood Dr. during heavy rain. Ken also persisted with the dispatch about its unacceptable delivery problems with this newspaper.

Ken's representation skills have also made an extraordinary impact on the entire 161 corridor. In one of the more memorable speeches I've heard, Ken addressed city council advocating for the tighter legislation that would clamp down on negligent hotel operators. Thanks to the successful passage of this law, it is a quicker, easier process to shut down those businesses who harm their neighbors through cheap profits.

While we celebrate Ken's successful presidency, we can do so with the knowledge that his service to your community remains ongoing. For his past actions as well as future achievements, I am personally grateful to Ken.

FOREST PARK CIVIC ASSOCIATION January 12, 2016 MINUTES

The meeting was called to order by 2015 President Ken Gilbert at 7:04pm and started with the Pledge of Allegiance by all in attendance. Roll call of the 2015 officers was taken by the secretary.

Starting the meeting President Ken Gilbert gave a review and thanked those who helped in his time as President for 2015. He also went over the past year accomplishments such as the new Hotel city laws, getting the Sandalwood/Yellowwood intersection fixed and pushed gaining volunteers for next year before introducing the 2016 slate of officers for the Forest Park Civic Association, they are as follows:

President Ed Vanasdale, Vice President and NCC Rep Felix Quachey, Treasure Dan Hartzell, Secretary Matt Ward, Public Relations Mary Sguerra, Forester Rita Woeste, Supplemental Security Felix Quachey, Past President Ken Gilbert, NCC Development Rep Dave Paul, Business Rep P.J.Phillips, Welcome Committee P.J. Phillips. Area Reps Include: (1) Wally Veasey (2) Bob Hinebaugh, (3) Jack Briggs, (5) Joe Krabill, (6) Linda Hancock, (8) Steven Dhuyvetter, (10) Scott Prigan, (11) Linda Whitmore, (12) Larry Markin, (13) George Schimdt, (14) Joyce Minor. This year's slate of board officers were approved by the board and sworn in to office by City Attorney Rick Pfieffer.

At 7:10 President Ed Vanasdale began his meeting by introducing the speaker for the evening Luka Papalko with Energy Choice Ohio part of the Public Utilities Commission of Ohio(PUCO). He spoke on the issue of residents having the choice to choose where their energy comes from with third party suppliers. Mr. Papalko said that residents just have to go to energychoice.ohio.gov and sign-up. Change will show on name on resident's monthly bill. On the website, residents will be able to look through suppliers and see the best options for cost based on their usage and contract lengths. Mr. Papalko also gave those in attendance ways to conserve energy by suggesting items such as LED light bulbs and having your energy company do an Energy Audit on your house to see where you could be saving money. He also stated that there are services that will take away old appliances when replaced with new energy saving ones. Finally, the service regarding people coming around to sell line insurance for utility lines was discussed. Luka did say that these were legit services but the solicitors are to follow the same regulations as any other services, need to be licensed and can only solicit under certain hours. Call the PUCO with any questions.

At 7:40 the floor was opened up to committee reports. Dick Graham and Scott Clinger were not in attendance, Ed Vanasdale offered to bring any issues to them, and none were spoken. Next Dan Hartzell gave the Treasure's report for December. The report showed income coming from the Forester and expenses going out to supplemental security, maintenance on the islands and welcome committee. Overall report for 2015 showed income outweighed expenses to keep funds in the positive. Dan also presented the 2016 budget which was voted on and approved by the board. PJ Phillips said in new member report that 32 new businesses have signed on to new memberships.

Felix Quachey gave the Security report saying that it has been quiet around Forest Park. The closing of the hotels has helped move some of the problems out also the cold winter blast is helping as well. Felix and Mary Squerra, public relations, both noted in their reports that they have gotten calls regarding cars being parked in the grass. They both said to call them if you see this as well as call the Columbus 311 number to file a report. Mary also stated she is looking for information regarding an accident that happened on the East island in order to help pay for the damage that was done. Rita Woeste continued the committee reports with her Forester report. She said articles were due January 22nd, for this month. She also stated that the teen help list will not be included unless she receives updated names of people willing to help residents. The Forester will try to be around 12 pages with extras being put at Gabbys, the YMCA, Library, Donato's and Dairy Queen. No Forester will be issued with the Directory this year. Direct mail options for the Forester are being looked into as well.

Felix Quachey returned with the NCC report which he attended his first meeting as the FPCA representative. He said he was happy to see the role we played in the NCC and their development. He stated that the Red Carpet Inn had been purchased by the owners of ABC Liquor with the intention of running a reputable hotel. The new Kroger store construction has started on Morse Road and Waste Management presented programs to help those who cannot get their trash to the curbs to help pick it up. Felix also stated that they are starting to look for parade volunteers for this year. Dave Paul discussed additional NCC news regarding development. He stated the Raintree Center is looking to expand and the Furniture Bank of Central Ohio is looking to move into the old Rite Rug storefront on Morse Road as a place to sell furniture pieces they cannot use for their apartment placements. He said the council has approved the move. Dave also stated that Ohio Mulch is looking into the abandoned house lots along 161 to open a retail space, but is waiting for city to re-zone the area for this. This also gives the city an opportunity to re-zone the area to add some restrictions that were not in the old zoning. Dave Paul also gave an update on memberships saying they have received the first ones for 2016. In the Outreach report, Mike Stone said they are going to focus on the number of people moving into the area as opportunities to grow membership among the residents of Forest Park.

At 8:10 new business was brought up with the 2016 Budget being voted on and approved. Felix Quachey updated the board on the insurance and advised to stay with what we had and to add lines for bonding the treasurer and director/ officer coverage.
