# **New Ideas for the Karl Road Library**

Recently I attended a meeting and I wanted to share with you some of my thoughts concerning the Design of the New Karl Road Library from the Community Input Meeting on February 28, 2019.



It was well organized. There were approximately 14 people that represented several groups that are working together to provide us with a new library. Those groups included: the CEO of the library, Director of the Karly Road Branch of the library, and heads of several departments at Karl Road, along with an architectural firm and other people. I had hoped they

would pass out an agenda of the meeting with those peoples' names listed, but alas, they did not. All persons were introduced; I just didn't get the names written down. Approximately 35 residents were in attendance; the room was full. Many questions were asked, made note of and answered in the allotted time. Four young people came into the meeting and actively listened and offered good suggestions. I was happy they chose to be there, as they are our future; they will be using the building over the next 40 years. Who knows, maybe one of them, when grown up, will be an architect and be able to design the next building!

Our new library is one of the four remaining libraries to be built in the Phase ll project. The design team thinks our library will be the first of the four rebuilt, because of the available surrounding land. The plan is for a 2 story, 40,000 square foot building to be constructed between the present library building and Karl Road. The plan is the present building will stay open during construction. The

Grand opening of the new construction is slated for the 2<sup>nd</sup> quarter of 2021.



In Phase I the Driving Park Library located on Livingston Ave in Columbus received a Gold

Award from Leadership in Energy and Environmental Design (LEED's) in 2014. The Whitehall Library on East Broad Street received a Silver Award from LEED's in 2015.

Take the best features of what they learned from those two libraries, adding our community's own desires and dreams (within the budget), will make our library be the best! Some of the ideas in previous libraries looked good on paper. They have found that some ideas failed in the newly constructed buildings. Those things were changed or eliminated from future plans. Corrections were made to those buildings as well.

As I write this, I realize that two topics were not mentioned. First the plans of parking spaces was not discussed nor was any security issues. Information has been gathered from a survey that was sent out by email to library card members(if you as a member chose to be contacted by email); it was also posted to the Nextdoor App for residents to complete 3 questions. This information, adding to the input of the meeting I attended, will be used in the process of developing several plans. It is my understanding that there will be

## **TOMATO PESTO TART**

1 9" frozen (thawed) or refrigerated pie crust (I use Pillsbury pie crust)

2 cups (8 oz.) shredded Part Skim 2% Mozzarella cheese, divided

4-6 plum tomatoes, sliced (I have made two layers of tomatoes)

1/4 cup mayo

1/4 cup Parmesan cheese, shredded

2 tablespoons Basil Pesto (found in Italian section at grocery)

1/8<sup>th</sup> teaspoon ground pepper

Sprinkle dried basil on top of dish after baking

If using Pillsbury pie crust, UNFOLD piecrust on a lightly greased 9" pie plate or a tart pan. Brush outer 1" of crust with water.

Place over pie baking dish and fold edges up and crimp.

Prick bottom of crust with fork.

(If using thawed 9" pie crust, prick bottom crust with fork and bake 8 -10 mins.), as indicated below.

BAKE at 425 degrees for 8 -10 minutes. Remove from oven and sprinkle with 1 cup of Mozzarella cheese; let cool for 15 minutes. Arrange tomato slices over cheese.

STIR remaining 1 cup Mozzarella cheese, mayo, and next 3 ingredients. Spread over tomato slices.



SET BAKING DISH ON A TRIVET TO COOL for

5-7 minutes so it cuts nicely.

Tasty with crisp salad/fresh green beans and crusty bread!
