- When an incident occurs, no matter how big or how small, always report it to the police department. The police use the numbers for allocating resources and patrol cars so the more accurate their information, the better. The non-emergency police number is 614-645-4545.
- Be aware of your surroundings and don't leave the garage door open when working in the backyard or leave it otherwise unattended.
- Lock your car door each and every time you exit your car. People routinely canvas the neighborhood and check for unlocked car doors and while we all agree that they shouldn't do that, the only way to deter them is to lock your car doors, don't leave valuables in your car, and report any incident to the police to increase patrols. Otherwise, you are only inviting them back into our neighborhood. Statistically, most crimes are crime of opportunity.
- If there is an issue, the appropriate contacts are the police for any crime (614-645-4545), 311 for any code violation issue (311), or your area rep for any questions regarding the Forest Park Civic Association (see the contact list in the front of the Forester).
- If you place a Supplemental Security Vacation Request, please provide the form at least one week before your vacation starts. Vacation requests can be sent to Daryl Van Mercetta at <u>dvanmercetta@gmail.com</u>, 2131 Honeytree Court, Columbus, OH 43229, 513-479-2416, or online at <u>fpcivic.org</u>.

Remember, Supplemental Security Vacation Requests are free with your paid Forest Park Civic Association Membership, which is only \$25.00 a year for the entire household! As always, if you see something, say something and stay safe everyone.
