Recruiting the Next Generation of Volunteers

In this article, I'm going to outline an improved plan for harnessing our neighborhood's most precious resource: resident volunteers. With the easing of virus-related restrictions and the growing passion for Forest Park, this is a perfect time for a reset.

Current Difficulty With Managing Our Volunteer Pool

FPCA has a PDF "Volunteer List" that is updated after every membership cycle. Residents who have returned their membership form and have checked their volunteer boxes are added. The same is true for those who are registered electronically. Previously, we have offered a large number of volunteer categories and this has been an unexpected problem. Volunteers who have checked too few of these boxes limit the chances of being contacted. We also have a large number of people who have not provided email contact information.

Improvements

To streamline this process, we have eliminated the number of volunteer categories. We are also moving to a greater electronic presence for everyone's benefit. Beginning with this membership cycle, we will update all contacts and design a new volunteer email list, along with a "Sign up Genius." When we encounter a need, we will send it out to the entire volunteer pool for (hopefully) quick and easy responses. In addition, we will also make announcements through our Facebook and Next Door pages.

If You Choose to Use Fireworks

If consumer fireworks are legal to buy where you live and you choose to use them, be sure to follow the following safety tips:

- Never allow young children to handle fireworks
- Older children should use them only under close adult supervision
- Never use fireworks while impaired by drugs or alcohol
- Anyone using fireworks or standing nearby should wear protective eyewear
- Never hold lighted fireworks in your hands
- Never light them indoors
- Only use them away from people, houses and flammable material
- Never point or throw fireworks at another person
- Only light one device at a time and maintain a safe distance after lighting
- Never ignite devices in a container
- Do not try to re-light or handle malfunctioning fireworks
- Soak both spent and unused fireworks in water for a few hours before discarding
- Keep a bucket of water nearby to fully extinguish fireworks that don't go off or in case of fire
- Never use illegal fireworks



Sparklers Can be Dangerous



Every year, young children can be found along parade routes and at festivals with sparklers in hand, but sparklers are a lot more dangerous than most people think.

Sparklers burn at about 2,000 degrees – hot enough to melt some metals. Sparklers can quickly ignite clothing, and children have received severe burns from dropping sparklers on their feet. According to the <u>National Fire Protection Association</u>, sparklers alone account for more than 25% of emergency room visits for fireworks injuries. <u>For children under 5 years of age, sparklers accounted for nearly half of the total estimated injuries.</u>

Consider using <u>safer alternatives</u>, such as glow sticks, confetti poppers or colored streamers.

The Forest Park Gardener

Enjoying the fireworks of July!

I believe that all the rain we received at the beginning of June, and the heat wave in the middle of the month have given our summer flowering plants what they need to put on a fantastic show. Summer blooms from the Daisys, Daylillies, Bee Balm, and Cone Flowers are getting ready to take front and center in the garden. Also, is anyone noticing how amazing the roses are this year?



What is the best way to keep the show going? Well, to quote the Red Queen from *Alice* in *Wonderland...* "OFF with their Heads"!

The whole purpose of the beautiful blooms is for pollination, seed production, and pro-creation. Plant sex, plain and simple. Once a plant accomplishes this feat, it will be happy to reserve its strength and not put forth any extra effort. Its energy is redirected toward growth and not flowers.

However, the gardener has some great tricks to keep the plant producing blooms.

Deadheading – cutting or pinching off the spent blossoms. By doing so, the plant will send up new blossoms. Regular deadheading will also cause the plant to become bushier, which will give you even more blooms. Hint: Keeping your mums pinched to an inch until July 4th will help ensure more beautiful mums in the fall.

Fertilizing – I know we feel like we just did this, but early July is a great time to fertilize one more time before the summer gets hot. If you bought the granular fertilizer, spread it around now, timing it with incoming rain events. Everyone enjoys a 4th of July picnic. Your plants need some extra food right now too! *Be careful if you are using a water base fertilizer that you don't spray it on the plants before the heat of the day.* It could encourage scorched leaves and even mildew (eew!). Do that in the early morning.

Weeding –Not my favorite part either, but weeds (which are plants who aggressively grow where they are not invited) can overtake your annuals and crowd them out of sun and water. Now is when we begin to see crabgrass, spurge, thistle, and oxalis (clover) really come on strong. While you are pinching off blooms, pluck the weeds as well.

Garden Dangers: Be careful that you do not run into these three amigos! If the leaves are 3 – leave it be (poison ivy).

Vines with purple flowers, berries (Nightshade) – poisonous especially for dogs. Poison Hemlock: looks like Queen Anne's Lace, be careful and be informed. https://www.youtube.com/watch?v=gAdz7r7jM0U

Lawn Care: Someone asked me about cutting grass going into July. Set your mower on a higher setting and try to take off no more than 1/3 of the grass. Leaving your grass a little higher this month saves stress on the grass, keeps moisture levels at the roots higher, and discourages weeds, since the bare ground is not in the sun.. Also – longer grass will encourage fireflies in your yard. If you water, make sure it is a deep water (1"), to keep strong roots.

Most important – don't forget to take care of yourself and wear your sun screen and mosquito repellant. Check for ticks, and stay hydrated. Enjoy the summer and the fireworks.

Meet folks from FPCA

Forest Park Representative to the Northland Community Council (NCC) is Ken Gilbert. Ken and his wife Catherine have lived in

Area 3 of Forest Park West since 2002. Ken came to Columbus from the Philadelphia area in 1978 to attend Ohio State as a graduate student in Chemistry, found a local church (Dwell Community Church) and a local girl there (Catherine is an 1981 graduate of Northland High School), and never left. They enjoy elephants, the Columbus Crew, and Penn State football—and they are owned by four cats. They have



served in multiple roles in the FPCA through the years. In 2021, Ken was asked by FPCA President Scott Prigan to serve as the FPCA Representative to the Northland Community Council, which is a coalition of civic associations, home-owners associations and other community groups in the Northland area. It represents over 130,000 area residents (25-square miles of the City of Columbus) and works with Columbus City Council, the Mid-Ohio Regional Planning Commission, and a wide array of other city, county, state and non-profit organizations to continuously enhance the prosperity and quality of life enjoyed throughout the Northland community. NCC also organizes the annual Northland Fourth of July Parade, which we hope will resume in 2022. See my notes below on discussion from the June meeting. Nice to be here and part of the Forest Park Civic Association!!

Homeless Shelters discussion at FPCA meeting

One recent area of interest to Forest Park residents that came before the NCC was a concern about the area shelters for the homeless that were opened on an emergency basis during COVID in 2020. About 7 years ago, the YWCA took over one of the old hotels north of 161 just west of I-71 as a swing space for women in transition during the renovations of the downtown YWCA. In 2016, the Columbus Housing Network and the Community Shelter Board requested a council variance to continue to use the hotel as a shared living facility for people in transition. In 2020, the Community Shelter Board leased two other hotels in the 161/I-71 Corridor to house the homeless on an emergency basis due to the impact of COVID. Representatives of these groups came to the June NCC meeting upon request to discuss these issues, as the community had not been notified before this happened. Members of the NCC were concerned about the increase in panhandling seen in 2020 and about this use for hotel stock in our community. It was noted by Ken that the community wants to and needs to be part of any solution, but we do not want Northland to bear the brunt of the solution. FPCA members took the lead in questioning the Community Shelter Board and YWCA representatives and expressed our concern that the community was not asked for input before these additional shelters were set up in our community. A vigorous discussion ensued. At this time, one shelter is expected to be closed in a couple of months, with the second closing in about a year. The shared living facility will remain. The NCC hopes to have these groups back in the future to discuss their ongoing plans. We invite FPCA members to share their concerns with the FPCA Board and the NCC, so that we can accurately reflect our community's concerns. This is just one example of the kinds of things that come up at an NCC meeting.

Together we can keep this the best neighborhood in Columbus!! I hope to see some of you at our next in person civic association meeting that is held the second Tuesday of the month at the Epworth Methodist Church.

A special thank you to, Officer Klinger, our neighborhood liaison to the Columbus Police Department who is retiring. We just love your updates at our meetings. You will be greatly missed!
