

# Supplemental Security News

Supplemental Hello Forest Park! We had our first post-pandemic in-person civic association meeting and it was great to see everyone in person! If we missed you, we hope to see you at the next one.

Ken Gilbert, our NCC representative, provided some information on the new **Safe Streets Program** run by the Columbus Division of Police. Their mission is to increase uniformed police presence in the hopes of deterring criminal activity. Dan Yandrich, and he can be reached at <a href="mailto:dyandrich@columbuspolice.org">dyandrich@columbuspolice.org</a>. We look forward to meeting Officer Yandrich, but in the meantime, the message remains the same: report, report, report. Reporting criminal activity is easy, simply:

- call the Telephone Reporting Unit at 614-645-4717
- call the non-emergency police at 614-645-4545
- "file an offense report" on the Columbus Police Mobile app
- use the police's website at <a href="https://www.columbus.gov/police/">https://www.columbus.gov/police/</a>.

Don't forget, if you're a paid Forest Park Civic Association member, supplemental security is an added perk of your \$25.00 annual membership. If you submit your vacation request to Daryl Van Mercetta, he will notify our



security company, who will then conduct patrols by your home while you travel. Your personal information, travel dates, etc. remains confidential. To submit your request, fill out the Supplemental Security form and return it to Daryl Van Mercetta at <a href="mailto:dvanmercetta@gmail.com">dvanmercetta@gmail.com</a>, provide the information to him over the phone at 513-479-2416, or submit the form online at <a href="mailto:www.fpcivic.org">www.fpcivic.org</a> and he will notify the security patrol, who will then report any suspicious or unexpected activity while you're away. Please be mindful that security requests should be placed a week or two prior to your planned travel dates and the security officer will only monitor your property; he will not collect packages/mail; take back your trashcans; or close your gate. Now is a great time to make friends with your neighbors, who can help with those tasks.

As always, if you see something, say something, and stay safe everyone!

# Creating a Certified Wildlife Habitat Garden

"Anyone, anywhere can restore wildlife habitat right in their own yards and communities," said National Wildlife Federation naturalist David Mizejewski. "Whether you garden in a suburban yard, an urban area or a rural plot of land, you can make a difference for local wildlife. Creating a Certified Wildlife Habitat garden is fun, easy and makes a real difference for neighborhood wildlife. It's the perfect grassroots way to think globally and act locally and help birds, butterflies, bees and other wildlife," he added.

My wife Julie and I just completed the certification process at our house on Ironwood Dr. where we have lived for 18 years. It was always something we were committed to, but we just never followed through with the certification process. This spring we made the commitment, it wasn't hard since we have been following many of the practices for many years. For example, we feed birds from fall to spring, we have a bird bath and rain barrel, we have bird houses, trees and shrubbery for the birds to nest in, we compost, and have been replacing many non-native plants (especially the invasive ones) with many Ohio natives. As many of you know, working in and improving your yard/garden is a continual process that can be fun and a lot of work, but why not let everyone know that you support your local wildlife while you are at it!

Below are the certification requirements and some benefits of the program (from the National Wildlife Federation website).

#### **Certification Requirements**

Certified Wildlife Habitat® applicants are asked to confirm they've provided the required number of elements for each of the following:

Food Water

Cover

Places to Raise Young

Sustainable Practices: capturing rainwater from your roof, removing non-native plants and animals, using organic fertilizers, etc.

#### **Benefits to Certification**

When you certify you will become a member of the National Wildlife Federation's Garden for Wildlife<sup>TM</sup> community and receive the following benefits:

Personalized certificate

A one-year membership in the National Wildlife Federation and subscription to National Wildlife® magazine Exclusive option to purchase attractive garden signs designating your garden as a Certified Wildlife Habitat® with the National Wildlife Federation


# Here's what goes in the blue cart:

# The Forest Park Gardener - August

The month of August represents the time of year where the garden begins to put forth its final effort, before it begins its preparation for the colder seasons. Now is when your pollinators should be blooming and showing their best color.



If you are like me, and enjoy canning or freezing some of the summer bounty for the fall, now is the time to check your supplies, your jars/lids, and – and your storage space. I have informed my family that I have a frozen turkey that we need to cook, so that I can free up a critical freezer shelf! If you are either bringing in your own produce, or supporting your local growers, August is the month to enjoy good local produce.

If you are an herb gardener, and want to dry some of your garden herbs, like your parsley and basil, now is the time to cut it and dry it. Cut the herb early in the morning, and either let it dry hanging is small bunches in a cool, area. Your garage or basement would work. I am not that patient. I dry my herbs by placing them on a baking sheet in a 200°F pre-heated oven. I put them in there for about 30 minutes, and then turn off the over and walk away. In about 2 hrs, they are dry. Let them cool, and then crumble them up. Store in airtight containers. I do know that some people like to freeze parsley in ice cubes to add to recipes in the fall. Either way, fresh herbs are so good.....

Maintenance in the garden continues! Pull weeds when you see them, and keep your plants watered during the dry periods. August is a high activity month for bees and pollinators, so keep your plants performing with deadheading (see July's newsletter). Adding mulch to bare spots will help with keeping weeds down.

I've had a problem with my Daisies and Coreopsis getting really leggy and flopping over. I have used a small garden stake and some green twine to tie them up so that they are supported, and not encroaching on other plants. I do *not* fertilize my plants in August. It is just too hot and dry. I will lightly fertilize perennials later in the fall, when it is cooler.
