## Hello Forest Park!

The temps are quickly dropping and that often leads to the temptation to let the car run unattended to heat up, but remember that it's not only illegal to do so, potentially earning you a ticket from CPD, but is far more likely to lead to it being stolen. (We already had some taken during the first cold snap of the season.) If possible, move it into the garage to keep it clear of snow and ice and relatively warm. If that's not an option, there are covers, seat warmers, and other such items that can help you tolerate the elements and keep from losing your vehicle to opportunistic thieves. Keep this in mind when you're at the gas station, running into a restaurant to grab food, or wherever your running vehicle is out of your sight; it only takes a second for someone to open the door, slide in, and take off.



Tis the season to have lots of gifts delivered, but remember that thieves are thinking the same thing. They'll be on the lookout for piles of boxes and/or blind spots that they can grab and go from your house. Protect yourself with a visible home security system, enlist the help of a neighbor if you won't be around, leave instructions with your delivery driver to place your purchases somewhere that isn't visible from the street, use lights/TV to give the appearance that you're home, or have them held at a pick-up location.

As a general rule, have a well lit home that appears occupied at all/odd times and having neighbors who look out for each other is a good crime deterrent.

Officer Yandrich said that the impound lot is full, so don't expect any problem parked cars to be towed anytime soon, but you can still report them because CPD will come out and ticket them; and those tickets add up. Call or file those through 311. File your reports of speeding vehicles, racing, dangerous driving, etc to 311 as well as through the CPD non-emergency line at 614-645-4545 and press \* at the prompt to get connected to a person.

Don't forget, if you are a paid Forest Park Civic Association member, which is \$25.00 per year for the entire household, Supplemental Security is included in your membership. To submit a supplemental security request, simply notify Daryl Van Mercetta online at [fpcivic.org](http://fpcivic.org), via email at [dvancouver@gmail.com](mailto:dvancouver@gmail.com), or mailing a copy of the enclosed form to him at 2131 Honeytree Court, Columbus, OH 43229.

On Saturday, Nov. 6th, three members of the FPCA Sign Committee (Ed Vanasdale, Daryl Van Mercetta, and Lou Bernard -- Scott Prigan was unable to attend) completed the final phase of the committee's project to reinstall 5 Forest Park signs.

Originally, there were 10 signs placed around the many entrances of Forest Park. But after many years of wear and tear and a bit of vandalism, only 5 of the signs remained and needed to be replaced. The signs were purchased from Moore Signs in Westerville. One of the employees, Curtis Moore, lives in Forest Park. The committee members had fantastic weather as they motored around Forest Park East and West hanging the new signs.

The signs were installed at the following intersections: Satinwood Blvd./Pegwood Ct., Kilbourne Ave./Northtowne Blvd., Minerva Park Place/Cleveland Ave., Teakwood Dr./Aqua St., and Maple Canyon Ave./Sumac Dr. The next phase of the project will entail discovering the former locations of the 5 missing signs, and determining what process is needed to get those reinstalled.

## Northland Community Council Update

The Northland Community Council is a coalition of civic associations, home-owners associations, and other community groups in the Northland area of Columbus, Ohio. It represents over 130,000 area residents (25-square miles of the City of Columbus) and works with Columbus City Council, the Mid-Ohio Regional Planning Commission, and a wide array of other city, county, state, and non-profit organizations to continuously enhance the prosperity and quality of life enjoyed throughout the Northland community. It meets on the first Tuesday of each month at 7 pm at the Westerwood retirement community, except August (our picnic) and December (holiday dinner). All area residents are welcome to attend. Forest Park is entitled to two representatives in the council.

At our November meeting, a number of items were discussed that might be of importance to the Forest Park community. One concern in our area has been the use of some motels to house the homeless. A group from the Community Shelter Board and the Y came to speak to us. There were three properties in question, two near the Continent and one on 161 (the old Motel 6). The first is a permanent supportive housing unit and has been there for about 5 years. The residents have leases and have rules and responsibilities. The second has closed, and the last one, on 161 is still open. It is being used during the COVID crisis to house homeless people who have contracted COVID. That is why residents have seen folks with cleaning apparatus etc. around the building. People who are there are restricted to the room and a balcony until they are well and released from care, and there are doctors and medical staff taking care of them.

Another ongoing concern is safety in some of the hotels in the area. The City Attorney's Office has objected to the renewal of the licenses of a couple of the hotels in the 161 Corridor, for failure to comply with the city's licensing rules. This is an area where the NCC has been active for many years with the City Attorney's Office and our local Columbus Police liaisons, as well as City Council, and this has resulted in the closure of some of the worse offenders in the Corridor in the past.

In other news, the Northland Fourth of July Parade will return in 2022. We have a parade committee that meets on the 3<sup>rd</sup> Saturday of the month from 1-2 pm at the new Karl Road library branch. Christine Osero and Mike Troolin are our committee chairs. See [northlandparade.org](http://northlandparade.org) for more information. The committee is looking for volunteers to help organize the parade. Forest Park has always been a major part of the parade, especially as it runs through the middle of our community. I encourage folks to turn out and help.

## Forest Park Gardener – December 2021

Normally, this is the time when I tell you to cuddle up with a hot chocolate and start planning your spring garden. Yet, it is hard to take this so seriously when I am in short sleeves, pulling up my canna bulbs. It just doesn't feel like Autumn yet, but as our local weather team is telling us, it is on the way.

I noticed when I pulled up the bulbs that they seem to have adapted to the hotter, dryer, weather we have had. They were buggers to pull out. The roots are long and deep. Much more than last year. Perhaps that is what we should be pondering over our Hot Chocolate this winter – how do we adapt our outside gardening to the changing climate. Now I'm not getting into the whole climate change debate here, but things are different, and will continue to be so.



Take a walk around your garden – and look at your perennials and shrubs. Do you remember a Hydrangea getting serious leaf scorch (too much hot sun)? Did your Shasta Daisies not bloom (Too much shade)? I have a few things that I have identified that will need to be moved in the Spring. They may do just fine where they are, but they will absolutely do better if I move them. I planted 2 trees in 2020, and they are starting to take off. My garden is transitioning from full sun to partial shade.

As your garden gets ready to rest for the winter, and you are planning for next year, don't forget to take care of the gardener. As an older gardener (there is no denying it), I don't have the strength or stamina that I used to, so I must adapt. In fact, I found out I have a slightly torn rotator cuff, and my Dr. said it was from repetitive weeding and pulling. Are you kidding me? So, this winter, I have PT and exercises to get it stronger.

It's hard to keep moving over the winter months. No sun, and so cold.

Move your bike indoors and put it on a trainer, go walk the metro parks which are glorious in the winter. And, if you are traveling to warmer climates – why not find a botanical garden to visit? Heading to Disney? 1 hr south of Orlando is Bok Gardens – in the middle of all the orange groves. Heading to Myrtle Beach? Look up Brookgreen Gardens, and their collection of statuary in the formal gardens. If you have a place that you like to visit, let me know. ## Poinsettias & Christmas

There's no denying that poinsettias make bright, festive decorations during winter months. But they're native to Central America, particularly southern Mexico, and they're actually colorful leaves, not flowers. So why do we consider them the official Christmas flowers anyway?

The reason we associate poinsettias with the holidays comes from an old Mexican legend. A young girl named Pepita was sad that she didn't have a gift to leave for the baby Jesus at Christmas Eve services. Her cousin tried to comfort her and said that Jesus would love any present from her, even the smallest one. With no money to buy a real gift, Pepita picked a bouquet of weeds that she walked past on the way to church. (Other versions of the story say an angel came to her and instructed her to pick the plants.) When she got there, she left the weeds at the bottom of the nativity scene. All of a sudden, the weeds transformed into beautiful red flowers. This is why Christmas colors are red and green.

From that day on, they became known as "Flores de Noche Buena," or "Flowers of the Holy Night."

Poinsettias get their American name from Joel Roberts Poinsett, the first U.S. ambassador to Mexico, who brought them to the states from Mexico in the early 1800s. They didn't become traditional holiday decorations until the entrepreneurial Ecke family started promoting them a century later. Paul Ecke Jr. sent free poinsettia plants to TV studios across the country, including "The Tonight Show" and Bob Hope's holiday specials. Eventually, the trend caught on, and now poinsettias are among the most popular plants sold in the U.S. Congress even declared December 12 to be National Poinsettia Day, the anniversary of Poinsett's death.

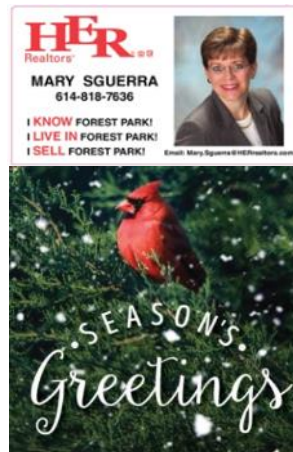
