## **Rezoning of Hotel property tabled by City's Development Commission**

The City of Columbus Development Commission in February voted to table an application that would allow the Community Shelter Board to rezone a hotel property at 1289 E. Dublin-Granville Rd. near Satinwood Dr. in Forest Park West.

The Community Shelter Board requested a rezoning of the property from Commercial to Residential. That would have permitted the use of the former Red Carpet Inn property for long-term, permanent housing for disabled homeless persons under lease to Homefull. The property includes 82 units (formerly hotel rooms). The Community Shelter Board and Homefull currently administer a similar property at a former hotel located at 1111 Mediterranean Ave. between Busch Blvd. and I-71.

The city's tabling of the application allows the applicant to return to the Commission with answers to the many concerns presented if they choose to pursue this rezoning.

The Commission indicated that it was otherwise prepared to vote against the rezoning. Unless the Community Shelter Board can overcome the many practical challenges of the location, this rezoning will likely not happen.

Thank you to more than 60 residents who attended the Forest Park Civic Association meeting in January on this issue and everyone who emailed comments to the city. Thank you to FPCA president Ed Vanasdale and NCC co-chair Dave Paul for their many hours of volunteer work (on this issue and many others).

At the city's hearing, the Northland Community Council's Development Commission co-chairs - including Forest Park East's Dave Paul - presented a argument that this location is not right for the proposed use of serving as permanent housing for disabled homeless people. Among many obstacles for success, he noted that the hotel is 52 years old, would require substantial

and expensive renovations to bring it up to code, is located on a highway with no green space or sidewalks, the building includes no common area, and it is not near a grocery or pharmacy.

The NCC Development Commission considered this application at its Jan. 26 meeting and voted 15-0 to recommend that the City of Columbus **DISAPPROVE** (reject) the rezoning.

The NCC and local residents were also concerned that the rezoning to Residential could allow future property owners or lease -holders to rent the units with little oversight.

The city's Development Commission agreed. Comments from the chairman included the following: "I think everyone agrees this is a terrible location... nothing in it lends itself to get modified for the use... the chaapest solution is to tear this building down... the changes required to bring it up to code for the proposed use is prohibitive."

As Dave Paul noted, "We want them to be successful, but we agree this is not the right location."

## **FPCA** Supplemental Security

Hello Forest Park! We have gotten reports that speeding in the **Supplemental** area has increased so the police are taking action in the Northland area (not just our portion of it), looking for speeders and giving out a lot of tickets. So, if you're a Linda or Larry Leadfoot, beware. Keep in mind that most of the roads that make up our neighborhood are only 25 MPH (the main arteries are mostly 30-35 and should be posted) maximum speed limit, so if it feels like you might be speeding, you probably are. This is to keep the neighborhood and residents of it safe and not just to be



speeder, add in a pinch of distracted driving, a person crossing the street or kid chasing a toy, and you have a recipe for disaster. In that same vein, going too far under the speed limit can be dangerous as well; especially on a main thoroughfare like Morse Road or SR 161. Know the rules of the road and if you're not sure about directions, pull over until you figure it out. Be sure to keep an eye out for the crime report from Officer Yandrich, located on page 6 of this March Forester.

2. Shout out to the FP Business Reps–2 new business memberships - Forest Park Christian School and Krieger Ford. Good work to our business membership team! And, to give a quick update, in February, we received business memberships from Cindy Fenstermaker, Massey's Pizza and Karl Road Christian Church.

3. At the end of January, we were \$250 over budget from what was projected for business memberships. With the three new ones, we are \$475 over! That definitely helps with our household membership shortfall of \$900.

4. Expenses are greatly reduced, with the final security patrols being paid and no payments for Forester Printing. We are currently positive cash flow to the tune of \$3,705.78. Remaining expenses that I am aware of for fiscal 2023 (ends March 31st), are the renewal of our post office box for approximately \$232. April Forester will be a hard copy and delivered. We probably want to carry over about \$2,800 into the next budget year (April 1st) as we'll need to renew our bulk mail permit and pay for the printing of the household data sheets before the membership income starts rolling. NOTE: there is still expense of the printed March Forester.

As a final note, Cheryl's husband is standing by to take over the advertising job. We haven't heard anything from anyone (though Massey's did pay \$40 for an ad).



- 1. Update: January 31, 2023, detectives have identified a suspect in this case and have filed warrants for his arrest. Travis D. Ingram Jr. has been charged with the murder of Mr. Charles T. Smith and the felonious assaults of M.S., S.W. and A.W. If you know the whereabouts of Mr. Ingram, please call the Columbus Police at 614-645-4730 or 614-461-TIPS (8477).
- 2. Update: January 29, 2023, 2:04pm, next of kin of victim #1 has been made, victim #1 is Charles T. Smith.
- 3. On January 29, 2023, at approximately 2:17am, officers were dispatched to the 1600 Block of Karl Ct. on the report of several people shot. Officers arrived at scene and found victim #1 suffering from an apparent gunshot wound. Officers rendered aid until CFD Medic #24 arrived and pronounced victim #1 deceased at 2:28am. Victims #2 and #3 were transported to a local hospital and are listed in stable condition. Victim #4, A.W., was grazed by a bullet and was treated at scene and released. Victim #1's information will be released once next of kin notification is made. ## **On-going Constuction at Maple Canyon & 161**

The first phase of long-awaited road improvements for the SR161 corridor from Cleveland Ave to I-71 are well underway at Maple Canyon Avenue. Improvements will include the addition of pedestrian and bike facilities, new traffic signals, pavement widening, resurfacing with raised medians, and the installation of roundabouts at Maple Canyon Ave.



The second phase will follow with improvements along SR161 from Maple Canyon Ave to Ambleside Dr including Beechcroft Rd and Tamarack/Sharon Woods Blvd north and south of SR161. These improvements will also include the addition of pedestrian and bike facilities, new traffic signals, pavement widening and resurfacing, raised medians on the side streets and mini roundabouts. An additional project will be undertaken on Maple Canyon north of SR161 to install sidewalk from the Fire Station to Jewett Dr. All this construction will require patience in dealing with traffic delays and detours, but in the end improvements to our infrastructure should result in better road safety and a better quality of life for all residents in Northland.

## Garden News - March 2023

As I'm writing this, we are 30 days until the first day of Spring. I don't know about you, but, to me it seemed like this winter never really got started. On a scale of one to ten, I would say this winter season was a 3. Cold enough to be annoying, punctuated with dramatic events (a snow storm or two, periods of sub zero weather), but all it all, it was tolerable. Although, it did seem like we had less days of sunshine and more days of the gloomy gray variety.

As I've said before, March is a transition month. Here is a check list of things to consider doing in March, to get ready for gardening in the spring.

MARCH, 2023

Clean your hand tools – Make sure all dirt/ soil is removed. The most common recommendation is a solution of 1:9 parts bleach to water. I tend to use Lysol, with a ratio of 1:5. If we've learned anything from



COVID, it's that "germs" linger. The process will kill any fungus, spores, or any other nasties that have been wintering over on your tool's surface. Whether or not you dip it or spray it, make sure to saturate the surface, and let it air dry. You should repeat this process several times through the season. For home gardeners this process should be sufficient.

If you are planning on moving or dividing perennials, later March is the perfect time. Dormant shrubs and evergreens can be transplanted, but wait until the end of the month, early April to make sure that they don't get frozen out.

Get your yearly supply of 12-12-12 (Nitrogen – Phosphorus – Potassium) Fertilizer. I start spreading it out under my evergreens, rhodies/azaleas, and sleeping perennials in early March. I always try to time it before a good rain. You can find this at the Garden stores, most hardware stores, and especially the Farmer supply stores.

Time to pick your seeds and collect your seed supplies. It's a good idea to wash your seed trays if you are reusing them, and always use new soil. READ YOUR SEED PACKET, to make sure if you can direct sow, or start the seeds indoors. Remember 6 weeks before our Frost Date of May 15th – that means you can start them around APRIL 3rd.

I talked to Ron Frost, Sales Director at Ohio Mulch, at this year's Home & Garden Show. Last year was a tough time for the industry as the mulching plants in Georgia had worker and supply issues. This year, it appears that they will have a good supply of mulch in all varieties.

Here's hoping that our Spring hangs around a while and we don't just leap into Summer
