Hello Forest Park!

Earth day is almost here! Did you know that the water that runs off your yard, driveways, and sidewalks and drains into the street runs directly to the waterways? Help keep our water clean by keeping drains clear and not washing hazardous chemicals into the street. If we each commit to keeping our yards and sidewalks clean and picking up one bag of litter while out in the neighborhood, our neighborhood and water will thank you.



We've been receiving complaints about parking issues, as 311 is taking a hiatus from towing vehicles, so we thought it would be a good time to send out a reminder of parking laws. Each of the following violations can get you a ticket and a \$50 fine:

- Parking within 10 feet of a fire hydrant. This can also get busted windows if the firetruck needs access.
- Parking within 20 feet of an intersection or a crosswalk.
- Parking on the sidewalk, curb, or tree lawn area.
- Parking in front of a driveway, Parking within 30 feet of a stop sign.

When parking on the street, you also have to park in the same direction as traffic, instead of against traffic, and semis cannot be parked on residential streets, including the circle. Not only is this the city code, this is part of being a good neighbor.

- 1. Discussed power outage last week. A large oak tree took out a major power line, 6 poles, and the back of a home. There was discussion about having AEP come to discuss general things to do in case of a power outage and other preventative measures. Ed will make calls to get a rep here as a guest speaker.
- 2. Cheryl Lutman discussed budget short falls and ways to address them. We are currently \$2300 in the hole. 2800 homes in FP, only 480 joined. We are going to run with the budget having a slight deficit, and hoping to get more households. FPCA Treasurer presented the 2023-24 proposed budget for the FPCA at the March 14th meeting. FPCA board members had met previously to find ways to cut costs. One suggestion is to cut printed publications of the Forester or cut security hours and those instances may happen depending on memberships we receive for the year.

Above is the proposed budget for the upcoming budget year of April 2023 to March 2024. This tentative budget will need to be voted on at our April 11th meeting at Epworth United Methodist Church on Karl Road at 7 pm. The Forest Park Gardener - April, 2023

I'm a bird lover. I admit it, I feed them, and I love the animation that it brings to my garden. However, I've been reading recent studies that indicate that this is not without risk. It can encourage the spread of Avian diseases, the alteration of migratory behavior, and the support of invasive species (aka House Sparrow!) to outcompete native birds (bluebirds, for one). I was astounded to learn that Americans spend over \$5 billion a year on bird food and feeders.



Are there ways to encourage our avian hobby and mitigate the risks? Of course, and in the long run, it will save us \$\$!


- 1. Consider adding Native Plants to your garden. These plants will provide nectar and seeds during the season. Consider plants that produce berries as well as blooms. Not only birds will benefit, but also the butterflies, and bees as well. When visiting the garden store, be sure to ask if plants you are considering, are native to our area. Many native species have been hybridized, to include new colors, or characteristics. Not all Coneflowers are alike!
- 2. Remember that not all birds eat seeds! Allow an area where you leave leaf debris, sticks, and brush, to encourage insect populations and give a secure area of protection for birds. This can be a man-made pile behind your shed, or a live area. For instance, between my house and my neighbor's, we have a tall privet hedge. It offers all the same benefits, as well as additional privacy. I can always see birds scratching around down there, especially during nesting season. And, when the Cooper Hawk, or Neighborhood Cats come around they have a place to hide!
- 3. Avoid or minimize the use of herbicide/insecticide and rodenticides. I'm not saying if you have a mouse problem that you don't take care of it but consider how it is being done.

A word about Native Plants: Many people get the words invasive and aggressive confused.

An *Invasive* Species refers to a plant that is not native to the area. It is normally something that is brought in, either intentionally or unintentionally. The Callery Pear, and Amur Honeysuckle are two good examples – they outcompete other species, causing damage to the ecosystem, and they don't stay contained in an area. A few examples we all know is Bishop's Weed and the dastardly Mock Strawberry.

An Aggressive Species refers to a plant that simply spreads in their immediate environment. Native Plants can be aggressive. Many gardeners purchase plants so that they will spread and fill in spots in the garden. However, these generally stay localized, and just create work for the gardener when they overgrow their targeted area—think Ostrich Ferns, Trumpet Creeper, and Mondarda (Bee Balm).

I've also had some questions about whether our Frost Date is changing. Historically the Last Spring Frost Date for our area has been May 15th. That is the date after which tender vegetation is safe to be inserted in the landscape (tomatoes, peppers, petunias, tropical hibiscus).

Hello Forest Park Neighbors!!

We have a beautiful neighborhood. Let's work together to keep it beautiful, clean and safe.

This is a reminder of things you can do to make your property more attractive.

- 1. Cut your hedges and mow your lawn in a timely manner. Over grown lawn and hedges can earn you a visit from the code enforcement division. (614-645-3111)
- 2. Keep your lawn free of trash down to the street gutters, don't let lawn cuttings clog up street gutters.
- 3. Call 614-645-3111 for bulk pick-up like old furniture and larger items that don't fit in your trash can
- 4. Green trash cans & Blue recycle cans should be placed beside your home or back yard until the night before pick-up.
- 5. Place those trash cans at the curb by your driveway no more than 12 hours prior to pick-up and remove them within 24 hours after the pick-up date.
- 6. Parking cars on the grass is not permissible, could earn another visit from code enforcement
- 7. Cars parked in your driveway should not block the sidewalk.
- 8. Permanent storage of your RV's, camping trailers and work/utility trailers should be behind the front line of your home on a paved surface. The city allows up to two days for loading/unloading campers in the driveway before and after a trip.
- 9. If you want to expand a driveway you need a zoning clearance from the City of Columbus
- 10. Inspect your sidewalks for debris and/or needed repairs. As a homeowner you are responsible for maintaining safe sidewalks. If the tree is between the street curb and sidewalk and causing to the sidewalk, the city will repair the problem but you need to call 614-645-3111 and file a request.
- 11. Speed limit in our neighborhood is 25 mph so please be aware of kids, folks walking dogs, and bike riders. Some kids are not always aware of oncoming cars.

Notes from Trevor Secord, NCC Rep, FPCA VP

Police - thefts of catalytic converters are way down so far. Doll House will stay closed until April 15th. Still can not impound any cars. Small thefts are occurring but are being tracked for upcoming arrests



Sara Pomeroy - Asst. City Attorney - They have sent the owners of the two local businesses who had shootings letters to inform them of the possible problem business. Runs at those locations are very limited. Doll House is closed until injunction hearing and liquor hearing. Most likely will not reopen. Hotels are on court orders and following procedures. Business benches are set for court hearings next week.

Col. Metro Library - library cards have benefits to a number of businesses for discounts. Go to the library website for a list of organizations. Working with National Geographic to bring an exhibit to give a Teen Art Showcase and monthly events highlighting cultural events. Events are available online to view from home or at the library.
