Blame it on El Niño ..

FP Gardener, March 2024

I think that we can agree that this winter has not made any sense. Other than the few true "winter" days in December, we've basically just been existing in a cold, gray, dreary landscape. Not a lot of rain, hardly any snow, and just really kind of non-descript.

Our winter season this year, has been courtesy of our friend "El Niño".

El Niño is a periodic weather pattern. Above average sea-surface temperatures develop somewhere in the Pacific Ocean, around the equator, and around the coast of South American and western United States. As a result, clouds form over the ocean, and ride the jet stream, crossing over the United States.

You would think that it wouldn't really affect us here in the Midwest, but it certainly does. In fact, because of the wobble and rotation of the Earth, the jet stream moves up and down. El Niño has global consequences.

In El Niño years, the West Coast of the US receive high amounts of participation. With all the rain California received this winter, their drought has been practically erased, and the ski resorts in Oregon and Utah are loving it! For our region, the jet stream pushes the colder air farther north, and we end up with a warmer and drier winter. If you noticed, Chicago and Detroit got most of the heavy snow this year, which went over the Great Lakes and dumped on Buffalo, Boston, NYC, and the Northeast. When the jet stream drops, it goes much further south – bringing colder air and strong storms to the Southeastern states.



While it might be nice to get away with wearing a fleece jacket instead of the full winter coat, the lack of snow and precipitation can really be a concern. Soils with below moisture levels tend to affect the planting of our gardens and especially the farmer's fields. Dry fields can lead to erosion, and in the home garden, perennials are more susceptible to "frost heave". Also, you might be tempted to plant too early, due to warmer temperatures, but be careful. Weather patterns can come and go.

Many scientists believed that we would experience a Super El Niño event this year, meaning much warmer, and drier than normal in our region. That being said, our El Niño pattern will come to an end, most likely in a slow fade. Around April we should see the normalization of the oceanic temperatures and we will settle back into a more "neutral" weather pattern.

Did I mention that El Niño has a sister? La Niña tends to show up after strong El Niño events. She is contrary to her brother, and brings cooler, wetter conditions. If we do have a La Niña pattern this year, you can look for her around late June, early July, and through August.

NCC Northland Community Council February 2024 meeting summary

The Northland Community Council held its monthly meeting on February 5 at Westerwood. These meetings are open meetings, and any resident of the Northland Area may attend. The following groups made reports: The Community Liaison Officers from the Columbus Police reported that the major issue in the Northland area is stolen cars, and it's not just limited to Kias and Hyundais. One of the big issues is folks warming up their cars without being inside them (this is a ticketable offense). It can take less than 30 seconds for someone to steal a car. Members of the Community Response Team were also present. Sarah Pomeroy, our zone attorney from the City Attorney's Office, reported on issues of concern to the community. She is continuing to work on objections to hotel and liquor licenses in the area, It was noted that there has been a few issues at the hotels near The Continent, as they are currently being used to house some of the people from the Colonial Apartments closure emergency. They hope to have all of those people rehoused in a few months. Many already are. The issues at the Beechwood Newsstand on 161 are being worked on. New lighting and security cameras are being added by the owners of the plaza.

There are many events going on at the Karl Road branch of the Columbus Metropolitan Library. Check the website for more info. The Northland Area Business Association will be holding their quarterly lunch at the Elevate Northland Center on March 12 at 11:30 am. Columbus City Schools will be holding a Summer Job Fair soon. Our Community Liaison Devin Deal noted a couple items of interest. The city is working on a flyer to promote home ownership. The Columbus Police's Citizens Police Academy is now taking applications for the next class. I know that FPCA president Ed Vanasdale has attended in the past and considered it quite useful.



There was an open roundtable with Brad Westall from Columbus Recreations and Parks about the purchase of the old rail right of way that parallels Westerville Rd from Linden up to 161 for a new park. More on that in a separate article.

The Northland Volunteer Awards Banquet will be at Villa Milano on April 16. Tickets may be purchased from the NCC website. The Northland Fourth of July Parade Committee meets at Casa Mescal on the third Tuesday of the month at 7 pm. The theme for this year's parade is Diamonds of Northland, as this will be the 60th parade.

Officers were elected by acclamation for 2024: President, Alicia Ward; Vice President, Pat Hammel; Secretary, Christine Otero; Treasurer, Roger Davidson. NCC Representative (Forest Park) Ken Gilbert conducted the election. No major items came from the NCC Development Committee. Finally a lively discussion took place regarding improvements to 161. We found out that the flower boxes are being removed and will not be replaced. There are currently no plans for anything other than very basic landscaping (i.e., grass) to replace them, as the roads department appears to have ignored our concerns. The NCC hopes to have a discussion on this issue with the city in the near future. It is hoped that there will be some grants available for beautification.

We have continued to experience the car theft and break-ins that tend to increase this time of year due to unattended vehicles warming up in driveways and the boys are still stealing Kias, but Officer Yandrich reported that crime in our area, the 18th precinct, is "normal."

What does "normal" mean? Normal just means that crime isn't above average, but it also means that it's not exceptionally below average. While that's good news, it can be better, which is why the Forest Park Civic Association reimplemented the Block Watch.



Per <u>usaonwatch.org</u>, here are the reasons to have a neighborhood block watch:

Basic Crime Prevention: Practice crime safety measures that eliminate opportunities for criminals. Encourage others to join in crime prevention efforts. Aid others when they become victims of crime. Work for a better and safer neighborhood through protecting and honoring the rights of others.

Disaster Preparedness: Learn skills to prepare for man-made and natural disasters. Local, state, and the federal government do a lot to prepare for disasters but citizens have to be ready to care for each other. Encourage citizen involvement in preparation and planning.

Build a Stronger Community: Get to know your neighbors. In our fast-paced world we don't spend enough time learning about our neighbors. Watch groups give community members a reason to get together and talk about making their community a better place. Neighborhood Watch Activities are a fun way for community members to get to know each other while making a difference.

The Forest Park Block Watch is held on the second Tuesday of every month at 6:00pm at the Epworth Church on Karl Road. It is the same day as the Forest Park Civic Association and at the same place. Our Police Liaison, Officer Yandrich, joins us at each meeting and dedicates 30 minutes of his time to provide us with updates of crime in the area, answer any questions we have, and address any concerns. If you cannot make the meeting, you can feel free to send any questions you have to Daryl Van Mercetta at dvanmercetta@gmail.com and he will bring them up for you.

Park & Greenspace planned for Eastern edge of North Columbus

Brad Westall of Columbus Recreation and Parks presented information on a new Columbus park, tentatively known as the Linden Green Line, at the Northland Community Council's February 2024 meeting.

This new park will consist mostly of the old CSX rail line right-of-way that once ran from Downtown Columbus through Westerville paralleling Cleveland Avenue and Westerville Rd.

A grant allowed the city to purchase the approximately 58 acres, 7 mile long corridor. The goal is to transform it into a linear park with a 10 ft shared use path, running from about Windsor Park at 17th Ave. to Cooper Park just north of 161. This could connect to the current bike trail in Westerville. Some of the old rail bridges and the tunnel under 161 may be able to be used, but a bridge over Morse Rd. will be needed. There will also be connections to other parks and the Alum Creek Trail with at least 40 access points to the new park.

There will be over 100,000 people in the area within 10 minutes of this new park in 13 neighborhoods. The original grant only covered the purchase of the park and some basic planning, so competing it will require requesting additional grant money. It will take 18 months to construct, and Parks and Recreation hopes to have it in service by 2026.

Food Waste Drop-Off Program

The City of Columbus is operating a Drop Off Composting site at Anheuser-Busch Sports Park, located on Olentangy River Road just south of Bethel Road.

(Bill McDonald Athletic Complex, 4990 Olentangy River Rd.)

It's a 24/7 site, and items you can drop include:

- --Fruits and vegetables, including peels, trimmings
- --Grains and beans
- -- Pastas, baked goods
- -- Eggs, eggshells, dairy
- --Small amounts of cooked or raw meats, seafood, shellfish
- --Small amounts of oil or grease

Remove any plastic or other wrappers.

I've been there, and it was really easy. Just pull in the parking lot and find the containers. Drop your food in (mind the bees!) and leave!

I started a sealed container on my counter and throw things in it. Then, every few weeks, I stop by the site and empty the container. Give it a wash and it's ready to collect more compost materials.

Until we get a drop off site going in the neighborhood, this is a great way to keep food waste out of the landfill!


