Memberships make

Welcome to the April 2024 *Forester* along with a membership application and information about the Forest Park Civic Association.

The yearly fees are only \$30—that's just \$2.50 per month. Out of the over 2800 households in our community, we received about 400 paid memberships last year. That's only 25% of our neighbors! We are hoping to increase membership to pre-pandemic numbers of 600+ members! Will you support your neighborhood?

Many ask, "So what do I get for my \$30 a year?" That money covers a wide variety of services of which you may not be aware. The majority of dues funds two main areas: 1) the production, printing, and delivery of our neighborhood newsletter "The Forester", and 2) our supplemental security budget which pays for a private security company to patrol our neighborhood streets and

monitor paid member homes when residents are away on vacation. Supplemental security also monitors vacant homes to deter vandalism. The FPCA has also restarted the Block Watch as an intricate part of the whole community. We are the only civic association in central Ohio that has a dedicated code issues meeting once a month where we can assist you in dealing with local code concerns. With more paid memberships, we can increase the number of patrols and patrol cars in the neighborhood—increasing safety and deterring crime which benefits all residents; not just paid members. Your paid membership also helps to fund our Social Activities Committee and the events they hold for the community, i.e. bowling days, National Night Out, Trunk or Treat, Pictures in the Park, etc. It also funds the Membership Committee's printing costs for membership forms and the folders used in our "Welcome to Forest Park" packets for new members. Funds are also used to cover the annual membership drive like we are having right now. Also, your membership helps to fund the community picnic and membership in the Northland Community Council, as well as many other things. These all play a part in keeping Forest Park strong and vibrant.

We would like you to remember that all members of the association board, officers, and representatives are 100% volunteers. They give of their time to keep our neighborhood a great place to live. Please become a member of our organization and do your part to help. We need to drastically increase

the membership numbers this year if we are going to maintain a strong and functional civic association in the future. We are glad you are part of our neighborhood and hope you can take the time to be involved in what Forest Park has to offer you. Thanks, and enjoy the season of Spring. - Ed Vanasdale, FPCA President



NCC Meeting Report March 5, 2024

Our standard reports from the Columbus Police Department, the Karl Rd Library, our Columbus Community Liaison, Columbus City Schools, and our (new) Columbus Community Engagement person, Harrison Poku-Yeboah took place. Highlights included a note that Columbus Police would like to have a presence at community events. They will be participating in community Easter egg hunts in March. Keep an eyé out for Rise Úp Columbus, an event coming from the City of Columbus. There will be more Keep Columbus Beautiful events once funding is approved in the next city budget. The library is worth checking out for a number of items, such as tax form and tickets to community events. Our City Zone Attorney noted that they are working on issues with the 161 hotels. Some were approved to take in residents from a couple of the apartment complexes that were closed at uninhabitable, such as the Colonial Village situation. The city and the Community Shelter Board hope to have these displaced residents rehoused soon. There have been increased police and fire runs, but this is mostly due to the larger

population in those hotels and family situations. The city is keeping a close eye on the problem locations.

We also had a list from the Deputy Chief Zone attorney, Tiara Ross, who spoke about a new training program for community policing. We hope to have more information on this program, which is open to Columbus residents, in the future. Our local state senator, Bill DeMora also put in an appearance, and there was a lively discussion of issues in our community.

The Northland Volunteer Awards Banquet will take place on April 16 at Villa Milano, Planning for the 2024 Northland Fourth of July Parade continues. Parade committee meetings are held at Casa Mescal on 161 on the third Tuesday of the month from 7 to 8 pm. And, it's Taco Tuesdays there! Volunteers throughout the community are welcome to attend. Myself, my wife Catherine, and FPCA President Ed Vanasdale have been volunteering for the parade for many years, but we could always use some more hands. The parade is important to Forest Park as we are the epicenter of much of the parade route. Note that the parade will kick off at 10 AM this year (to help some of our marchers who participate in multiple events on the Fourth).

Dave Paul reported on the NCC Development Committee. There were no major issues in our area. The same was true for the Graphics and Code Task Force. On a final note, I attended the quarterly Northland Area Business Association's (NABA) lunch at the new Elevate Northland HQ, just south of the Skate Zone near Morse and I-71. I'd encourage any business owners in the area to attend, as it's a good way to make connections in the neighborhood. Good food too!

The next meeting of the Northland Community Council will be in the auditorium at Westerwood, on April 2, at 7 pm. All area residents are welcome.

Hello Forest Park! The Columbus Police Department is currently understaffed and the population in Columbus is expected to keep increasing. That's not meant to frighten anyone, Supplemental but is meant to be a warning that we all need to be watching out for ourselves and each other. One very important way to do that is to submit the \$30 for your annual FPCA membership, because part of that money goes towards paying for the security patrols that monitor both Forest Park East and West. Supplemental Security also offers peace of mind while you're away from home by providing additional patrols when you submit your vacation request form. The best defense is a good offense and we can do that as a community by getting to know your neighbors, vehicles on your street, and by not making yourself an easy victim by leaving car doors unlocked and valuables in your vehicle. The approaching spring is a great time to introduce yourselves while working around the yard.



Another benefit of the \$30 membership is the Block Watch. We hold the block watch every month on the second Tuesday of the month at 6pm at Epworth Church on Karl Road. It is the same day and the same location as the Civic Association meeting. Our police liaison, Officer Yandrich, is present during block watch and it's a dedicated time to ask questions, get answers, and share concerns. Forest Park Gardener - April 2024

Well, this is to be a very exciting time for us in Central Ohio! The much-anticipated Solar Eclipse will be coming to our neck of the woods on April 8th. While we are not in the path of a total eclipse, we will still experience an amazing natural event. The next one won't be seen in the US until August 2044.



According to National Eclipse, Ohio residents can first see the moon overtake the sun at 1:53 p.m. before it fully reappears at 4:30 p.m. For those of you who are aiming for totality, it will last only about 10 minutes, starting around 3:08pm.

Be patient, not only with the Moon moving in front of the Sun, but also with the added crowds, traffic, and general hub bub associated with the event. I'm not sure how crowded it is going to be around here, but in the areas of "totality" it's going to look like a scene from "Independence Day", or "Ghostbusters" .. take your pick.

Wear the right glasses! Your Ray Ban's aren't going to help you. Make sure you have the correct safety gear, and leave them on!



While we are gazing skyward, it might be fun to check out the effect of what the eclipse does to our gardens. As the eclipse progresses, and the sun rays diminish, we might be able to see our plants get a little confused. Without the sun, photosynthesis shuts down, and plants leaves will droop, and buds may close. Many insects (butterflies, bees, etc) may begin their nighttime routines, heading to their homes or seeking shelter. Birds may quiet down, thinking it is night time, and crickets may chirp up!

I'm hoping that we have good weather and not the Central Ohio cloud cover that we normally get in the Spring.

Recycling: Using the Blue Cans

I've noticed in my jaunts around Forest Park that many residents are using the blue recycling containers. That's awesome. However, I have also notice that many are using them incorrectly. Two examples—at one house being cleaned out, I saw construction materials and old blinds in the container. Elsewhere, I've seen items for recycling being placed in plastic bags. Both are no-nos. They can actually result in the entire truckload being rejected and sent to the landfill. Plastic bags are a big issue as they can jam up the sorting machines. So can things like wires, hoses, and clothing.

A detailed list of acceptable items may be found on the city's webpage at https://new.columbus.gov/Services/Trash-Recycling-Bulk-Collection/How-to-Dispose-or-Recycle/How-to-Recycle, but we will give a short listing here.

- Cardboard and paper (flatten please)
- plastic bottles, jugs, tubs, and cups (lids accepted, remove straws)
- glass bottles and jars—all colors accepted
- metal cans and cups (remove aerosol tips)
- cartons (rinse and remove lids)

Don't put dirty cans or other items in—rinse them first. You do not have to separate items, and lids, caps, and labels may be kept on the items. Do NOT put in plastic bags, wrap, or film, do NOT put in other plastics not on the "good" list, and do NOT put in any kind of styrofoam items (like plates). Again, do NOT use plastic bags for your recycling. At our house, we use paper bags (which you can ask for at many groceries when bagging your purchases), which does make it easier to store and to recycle items. Also, do not recycle electronics. There are private recycling places in Franklin County that will take electronics for recycling and sometimes will pay you for them (excepting old tube TVs—which the city will pick up if you use their bulk pickup program).

In Forest Park, our recycling day is Friday, except when there's a holiday that week. In that case it moves to Saturday. Yard waste is collected separately, every other week. See the city's 311 website for more information.



Parking in the Neighborhood



There have been some recent questions about parking on the streets in FP.

FPCA recommends talking with your neighbors about parking issues. We realize folks are worried about cars parked on streets getting side swiped so they are parking up on the curbs or into the lawn. Be careful how and where you park and don't disturb the neighbors property when parking or driving from your location. You can always file your concerns with 311 Columbus as well.

We Found this list from Nick Renford at the website www.smart-parkings.com. Here is his list for parking Etiquette in the neighborhood.

- Always park in designated areas and avoid blocking driveways or fire hydrants.
- Be mindful of the amount of space you take up when parking on the street, especially in tight neighborhoods.
- Do not park on someone else's lawn or property without their permission.
- Respect parking restrictions such as time limits and permit-only zones.
- Be considerate of your neighbors and avoid making excessive noise when entering or exiting your vehicle.
- If you have guests over, make sure they are aware of the parking rules in the neighborhood and where they can park legally.
- If you notice a neighbor consistently violating parking etiquette, try to address the issue politely before involving authorities.


